CORRIGENDUM

In the Order-in-Appeal No.RAJ-EXCUS-000-APP-025 TO 029-2023 dated 31.01.2023, paragraph number 2.2 may be correctly read as under:

"2.2 Based on the documents seized during search and statements recorded, it appeared that the appellant No.1 had clandestinely cleared excisable goods during the period from November 2014 to December 2015 valued at Rs.1,51,16,390/- involving total Central Excise duty amounting to Rs.18,86,651/-. Show Cause Notice dated 02.12.2019 was issued to Appellant No.1 calling them to show cause as to why Central Excise duty amounting to Rs.18,86,651/- should not be demanded and recovered from them under proviso to Section 11A(4) of the erstwhile Central Excise Act, 1944 (*hereinafter referred to as "Act"*) along with interest under Section 11AA of the Act and also proposing imposition of penalty under Section 11AC of the Act and fine in lieu of confiscation under Section 34 of the Act. The Show Cause Notice also proposed imposition of penalty upon Appellant No.2 to 5 under Rule 26(1) of the Central Excise Rules, 2002 (*hereinafter referred to as "Rules"*)."
